**COMPENSATION COMMISSION
CITY OF GAYLORD, MICHIGAN
Ord. No. 112789 eff. Jan. 2, 1990**

An ordinance to create a Compensation Commission to determine the salaries of elected officials of the City of Gaylord: To establish the qualifications, term of office, time of appointment, vacancies, eligibility, restrictions, and procedures.

THE CITY OF GAYLORD ORDAINS:

Sec. 1. CREATION.

As authorized by 1972 P.A. 8 a local officers Compensation Commission is created which shall determine the salaries of each local elected official.

Sec. 2. MEMBERSHIP, TERMS, VACANCIES.

The Commission shall consist of five (5) members who shall be registered electors of the City, appointed by the Mayor subject to confirmation by a majority of the members elected and serving on the City Council. The terms of office shall be five (5) years, except that of the members first appointed, one (1) each shall be appointed for terms of one (1), two (2), three (3), four (4), and five (5) years. The first members shall be appointed within thirty (30) days after the effective date of this ordinance. Members other than the first members shall be appointed before October 1 of the year of appointment. Vacancies shall be filled for the remainder of the unexpired term. A member or employee of the legislative, judicial, or executive branch of government or a member of the immediate family of a member or employee of the legislative, judicial, or executive branch of government shall not be a member of the Commission.

Sec. 3. DETERMINATION OF SALARIES, EXPENSE ALLOWANCES OR REIMBURSEMENTS.

The Commission shall determine the salary of each local elected official for the performance of those duties specified for such officer in the City Charter. The determination shall be the salary unless the City Council, by resolution adopted by two-thirds (2/3rds) of the members elected to and serving on the City Council, rejects it. The determination of the Commission shall be effective thirty (30) days following its filing with the city Clerk unless rejected by the City Council. If the determination is rejected, the existing salary shall prevail. The expense allowance or reimbursement paid to elected officials in addition to salary shall be for expenses incurred in the course of City business and accounted for to the City.

12.124 **Sec. 4. MEETINGS OF COMMISSION; QUORUM; CONCURRENCE OF MAJORITY; CHAIRPERSON; SESSION DAYS; COMPENSATION.**

- a. The Commission shall meet for not more than fifteen (15) session days in each odd numbered year and shall make its determination within forty-five (45) calendar days after its first meeting.
- b. A majority of the members of the Commission constitutes a quorum for conducting the business of the Commission. The Commission shall not take action or make a determination without a concurrence of a majority of the members appointed and serving on the Commission.
- c. The Commission shall elect a chairperson from among its members.
- d. As used in this section, "session day" means a calendar day on which the Commission meets and a quorum is present.
- e. The members of a Commission shall not receive compensation, but shall be entitled to actual and necessary expenses incurred in the performance of official duties.

12.125 **Sec. 5. OPEN MEETINGS.**

The business which the Commission may perform shall be conducted at a public meeting of the Commission held in compliance with Act No. 267 of the Public Acts of 1976, being Sections 15.261 to 15.275 of the Michigan Compiled Laws. Public notice of the time, date, and place of the meeting of the Commission shall be given in the manner required by Act No. 267 of the Public Acts of 1976.

12.126 **Sec. 6. TERM OF OFFICE.**

For the purpose of this article, unless otherwise specified, a term of office shall be deemed to commence on Monday following each regular City election.

12.127 **Sec. 7. OTHER COMPENSATION.**

Any additional compensation to be received by any elected official for the performance of duties assigned by the City Manager (outside the scope of duties specified for such official in the City Charter) shall be set by the City Manager, subject to confirmation by the City Council.

12.128 **Sec. 8. REPEALER.**

In accordance with MCL 117.5c, any provision in the City Charter governing or relating to salaries or compensation of elected officials shall be inapplicable for so long as this ordinance is in effect. The provisions of Sections 2501 through 2507 (12.121 through 12.127) are hereby repealed.

12.129 **Sec. 9. EFFECTIVE DATE.**

This Ordinance shall be effective upon due passage and in accordance with the provisions of the Gaylord City Charter.
