April 12, 2021

Mayor Wishart opened the regular meeting of the Gaylord City Council with a prayer by Council Member Awrey at 7:00pm on Monday, April 12, 2021. The Pledge of Allegiance followed the invocation.

The meeting was held in the City Council Chambers, located at City Hall, 305 East Main Street, Gaylord, Michigan. Council chambers were set up per social distancing guidelines. The meeting was available to members of the public virtually, via Zoom.

Members Present: Mayor Wishart, Sharrard, Hartz, Ouellette, Awrey, Witt and Sides.

Members Absent: None.

Motion by Hartz, supported by Sides to dispense with the reading of the minutes from the March 22, 2021 meeting and accept them as presented.

Ayes: Unanimous. Motion Carried.

Public Comment: Robert Hines, 2455 Otsego, spoke on the marihuana ordinance. He reiterated having gone through the process, he feels the council is doing a great job and doing it right working with the community.

Johnathon Burke, 314 E. Main Street, stated that it seems as though the council is open to the M1 and C2 districts regarding the marihuana ordinance. Through conversations, he has heard that the ordinance is being put through to avoid litigation. He feels that if an unlimited number is set, there will be problems, he suggests doing a limited amount and see how it goes. May be litigation either way, error on the side of caution and do a fair and equitable process.

Drew Spanding gave an update regarding the Big Ticket Festival. The festival will be held July 9, 10 & 11, 2021. The committee is planning for a church service for the whole community on Sunday. He said the committee is keeping up to date with the rules and regulations regarding Covid-19 and will look into having mitigation measures in place. He will return to next council meeting to ask permission for use of city property for the festival.
