January 9, 2023

Mayor Sharrard opened the regular meeting of the Gaylord City Council with a prayer by Councilmember Wilson at 7:00pm on Monday, January 9, 2023. The Pledge of Allegiance followed the invocation.

The meeting was held in the City Council Chambers, located at City Hall, 305 East Main Street, Gaylord, Michigan.

Members Present: Sharrard, Ouellette, Witt, Hartz, Awrey, Ryan, and Wilson.

Motion by Ouellette, supported by Ryan to dispense with the reading of the minutes from the December 12, 2022 meeting and accept them as presented.

Ayes: Unanimous. Motion Carried.

**Public Hearings:** 

Public Hearing #1 regarding the Notice and Order to Show Cause (Michael Kliemann, 136 Jenson) opened at 7:02PM. Mr. Kliemann was present and informed the council that North Central Excavating is scheduled to do a tear-down on January 16, 2023. A permit has been pulled; the structure will be leveled for the winter and rebuilt in the Spring.

Public Hearing #2 regarding the Potential Development 18+ acres of City Owned Property opened at 7:06PM.

Jennifer Johnson, Captain of the Seventh District Headquarters of the Michigan State Police spoke to council. There is a desperate need for a new post. Looking at building a consolidated facility. There is no completed date set; just in need of securing the property to be able to move forward.

Representatives from Habitat for Humanity spoke and are also interested in the 18+ city owned property. They are applying for a million dollar grant; hoping to combat and solve the housing crisis. Would like to build in increments, building 9 homes within 3 years. After the first 16 homes are built, they will be able to see what the market is. Their focus is on the middle working class. Would have to seek matching funds for the infrastructure. Funds will go back to the state if there is no application made.

Lisa Macomb from the Otsego County Economic Alliance shared information regarding the housing assessment. Her request to council was to have the property go to developers to help solve the housing crisis in our county.

Marcy Beauchesne had two questions regarding the property taxes and what the priority is for the property; she would like to see the property granted to housing development.

Public Hearing #3 regarding the Non Use Variance Request (JVM Real Estate, 2325 Grey Wolf Pkwy) opened at 7:34PM.

Joe Messenger spoke regarding his request. The request is to have a wood frame building; it is more financially feasible to build with wood.

Todd Seidel, Mr. Messenger's architect also spoke to council. Bylaws indicate that no wood frame building shall be permitted without the written approval of the City of Gaylord. He stated that was the reason for the variance request. They would like to move forward in the Spring and start construction.

Public Hearing #4 regarding the 425 Agreement – Transfer of Property, M32 Group Third Amendment opened at 7:40PM. No comments were received.

All Public Hearings closed at 7:42PM

No Public Comment.
