Stephanie Fahler, on behalf of the Gaylord Farmer's Cooperative, requested to run a farmer's market under the pavilion for the 2023 season, and answered questions asked by the DDA directors in regards to her proposed farmer's market.

Bill Holowinski gave his remarks in regards to his history of farming in Otsego County, the difficulties farmers face, and his opinions of the current farmers market.

Mike Burzynski addressed the DDA board and requested renewal of his pavilion lease agreement which would allow him to run his Pavilion Market under the Pavilion for the 2023 farmers market.

Kelley Lang gave remarks about the farmers market. Stated she wants to vend at the market regardless of who runs it, but the 2022 season was the best year for her at the market and she liked the booth space Mike made available to her.

Melinda Neff gave her remarks about the famers market.

Motion by Steinbrecher, support by Kosch to renew the Pavilion Lease Agreement with Mike Burzynski of the Pavilion Market for the 2023 market season. Ayes: Unanimous. Motion carried.

City of Gaylord Treasurer Travis Hewitt address the DDA board and provided an update in regards to moving the DDA's funds from Fifth Third Bank to Horizon Bank and let the DDA board know the move was complete. Hewitt also presented the DDA with the option of investing funds into a CD with Horizon. Motion was made by Sharrard, with support by Reynolds, for City Treasurer Hewitt and DDA Treasurer Reynolds to coordinate the investment of DDA funds into a 30 day CD. Ayes: Unanimous. Motion carried.

There being no further business for discussion, motion by Muellenberg, with support by Reynolds to adjourn.
