## September 11, 2023

Mayor Sharrard opened the regular meeting of the Gaylord City Council with a prayer by Councilmember Ouellette at 7:00pm on Monday, September 11, 2023. The Pledge of Allegiance followed the invocation. The meeting was held in the City Council Chambers, located at City Hall, 305 East Main Street, Gaylord, Michigan.

Members Present: Sharrard, Awrey, Ouellette, Ryan, Wilson and Witt.

Motion by Witt, supported by Ouellette to dispense with the reading of the minutes from the August 28, 2023 meeting and accept them as presented.

Ayes: Unanimous. Motion Carried.

Motion by Witt, supported by Wilson to excuse councilmember Hartz from tonight's meeting.

Ayes: Unanimous. Motion Carried.

Public Comment:

M. Conn, C. Vantil, D. Conn spoke about their concern regarding the boarding house in their neighborhood which is in the R-2 district.

L. Correll spoke regarding his attendance at public meetings. He encouraged council to be open and proactive, hear the people and respond accordingly.

**New Business:** 

Motion by Ouellette, supported by Wilson to approve the following resolution to repurchase Lot #18 in the Industrial Park. (Note: Additional costs for closing and title insurance may be incurred)

On July 28, 2021, the City of Gaylord sold a parcel of real property to **Green Matrix, LLC**, situated in the State of Michigan, County of Otsego, City of Gaylord, legally described as:

Lot 18, Gaylord Industrial Park, according to the Plat thereof as recorded in Liber 5 of Plats, Page 27, Otsego County Records.

Commonly known as **1835 Wolverine Pkwy, Gaylord, MI 49735** ("the lot"), for which it tendered **\$85,780.00** to the City as the purchase price plus costs.

The City reserved the right under Paragraph 6.06 of the restrictive covenants, as recorded at Liber 1005, Page 678, Otsego County Records, and as last amended ("the covenant") to refund the purchase price to the buyer of the lot and to retake possession if construction was not commenced within two years from the date of sale, that date being July 28, 2023.

As of July 28, 2023, construction had not commenced on the lot.

The City finds that it would be in the best interest of the citizens of the City of Gaylord to exercise its right under the covenant to refund the purchase price and retake ownership of the lot.

**NOW, THEREFORE, IT IS RESOLVED** that the City exercise its right under the covenant to refund **\$85,780.00** to **Green Matrix, LLC** and pay the associated costs to retake fee ownership of the lot.

**IT IS FURTHER RESOLVED** that Mayor Todd Sharrard and Clerk Jennifer Molski are authorized to execute all documents on behalf of the City of Gaylord necessary to effectuate the above transaction.

Motion by Witt, supported by Wilson to approve the Marihuana License Renewal for Fresh Coast Provisioning, LLC (Dunegrass) at 2678 S. Otsego Avenue.

Motion by Witt, supported by Awrey to approve the Marihuana License Renewal for Great Lakes Exotics at 2625 S. Otsego Avenue.

Ayes: Unanimous. Motion Carried.

Motion by Witt, supported by Wilson to approve the Marihuana License Renewal for Great Lakes Exotics at 820 W. Main Street.

Ayes: Unanimous. Motion Carried.

Motion by Witt, supported by Ouellette to approve the Change Order #3 for the Fifth Street Project in the amount of \$2,954.84. The change order was submitted due to missing payment on cleanouts that were installed by the contractor during the project.

Ayes: Unanimous. Motion Carried.

Motion by Witt, supported by Awrey to approve the Non-Use Variance Request from Ray's Family Center at 931 S. Otsego Avenue with the condition of complying with the ordinance.

Ayes: Unanimous. Motion Carried.

Motion by Witt, supported by Wilson to approve the Use Variance Request from Korson Properties at 2361 Grey Wolf Pkwy. The request is as follows: (1) obtain permission from council to approve wood framing and (2) metal siding and roofing is required by industrial park but a variance is necessary per city ordinance.

(Note: the request was inadvertently submitted on the wrong form, therefore, it was approved as a Non-Use Variance Request and shall conform to conditions of a Non-Use)

Ayes: Unanimous. Motion Carried.

Motion by Ouellette, supported by Wilson to approve the request from Edgewood Holdings to pave the <u>city</u> <u>owned alleyway</u>; Block 14, between S. Illinois and S. Indiana between second and fourth (paving between the current buildings).

Ayes: Unanimous. Motion Carried.

Joe Messenger, Gaylord Funeral Home addressed council regarding a letter he received from the City that stated "no winter burials will be permitted between October 1<sup>st</sup> and April 15<sup>th</sup> except at the discretion of the City Manager or City Clerk (weather permitting)" as stated in the ordinance. Mr. Messenger requested council change the ordinance.
