

Training Strategy (Council/PC/DDA/ZBA)

Training Framework

Why: Continued training is important, especially in this era of unprecedented change. Local government is more important now than ever before. The public rightly expects responsiveness and accountability from their elected officials, and the local level is where citizens can directly experience the difference that good decision-making and ethical standards can make in a community. Elected and appointed officials, mindful of the liability exposures to the municipality, should be aware of established best practices and their relevance to the city of Gaylord.

Funding: The city has allocated funding in its annual budget for the training of elected officials and appointed boards and commissions. Outside funding may also be available from outside sources such as the Michigan Municipal League, Michigan Association of Planning, or our insurance provider. Members of the city council (in its capacity as zoning board of appeals and otherwise), planning commission, and downtown development authority, as well as city staff make more informed decisions based upon the latest information when they receive adequate training on land use and development issues. Turnover in officials and staff can create gaps in knowledge, which makes ongoing training essential to efficient functioning of the City's development processes.

Consistent Encouragement: The city should incorporate the discussion for training within an existing agenda item. This offers a chance to remind members of upcoming training opportunities, allow time for at-meeting training, and encourage report outs from trainings attended. The staff liaison for each board should inform the board monthly via email of training opportunities.

Sharing Outcomes: City officials (elected or appointed) will be encouraged to provide a short verbal report at the next meeting following any training event and share any materials gathered.

Primary goals: The city should establish the following goals for training:

- 1. Provide at meeting training opportunities for each board.
- 2. Every board member should complete at least 1 outside training opportunity per year.

3. Tie training opportunities to established goals from the City plans.

Training Methods: City staff will plan at-meeting training events for each board. These could be short presentations, watching a video together, attending a webinar, discussing an article, etc. The City encourages officials to pursue training methods which work best for them individually outside of meetings such as conferences, webinars, podcasts, or videos. Training should be a combination of new information and the basics to help officials stay up to date on existing documents and responsibilities.

Community Partnerships: Possible partnerships for training are with the Otsego Community Foundation, Otsego County Economic Alliance, National League of Cities, etc. (more examples on resource page).
