The City of Gaylord and the Township of Livingston have reviewed a draft Interlocal Revenue

Sharing Agreement, for the annexation of a parking lot along Winifred Road, Livingston Township,

Otsego County, Michigan, legally described as:

Parcel 2: The East 66 feet of Lot 77 and all of Lot 78 and the West 66 feet of Lot 79, West Gaylord, according to the plat thereof as recorded in Liber 1 of Plats, Page 18, Livingston Township, Otsego County, Michigan.

Tax ID NO. 081-210-000-077-01

("the Property"), to the City of Gaylord pursuant to MCL 117.9(8). The interlocal agreement provides for the sharing of three and one-quarter (3.25) Mills times the taxable value of the Property to be paid out of revenue collected from *ad valorem* real property taxes by the City of Gaylord to the Township of Livingston for a period of fifteen (15) years. The City of Gaylord has held a public hearing on the terms of the Interlocal Agreement as required under MCL 124.505a with at least ten (10) days prior written notice of said hearing.

It appears that the Property is contiguous with the boundaries of the City of Gaylord. Further, annexation of the subject Property and the Interlocal Revenue Sharing Agreement will promote economic development on the Property and is in the best interest of the City of Gaylord.

On September 22, 2025, the Township of Livingston entered into an Interlocal Revenue Sharing Agreement with the City of Gaylord. Under that agreement, the Township of Livingston agreed that it would resolve to annex certain property described below to the City of Gaylord under MCL 117.9(8). The Livingston Township Clerk has received a Petition signed by every qualified voter residing in the property subject to the agreement and signed by the legal and/or equitable owners who collectively hold more than one-half of the area of the land subject to the agreement. That Petition requests that the Livingston Township Board approves the annexation of the property described below to the City of Gaylord. The Livingston Township Treasurer has, at least ten (10) days prior to the date of this Resolution, notified the owners of all real property in the territory to be annexed either personally or by registered mail with return receipt demanded, at the last known address on file with the Township Treasurer, or has received a waiver of such notice.

NOW, THEREFORE, IT IS RESOLVED:

That the Gaylord City Council consents to and approves the annexation of the following described real property located in Livingston Township, Otsego County, Michigan, legally described as:

Parcel 2: The East 66 feet of Lot 77 and all of Lot 78 and the West 66 feet of Lot 79, West Gaylord, according to the plat thereof as recorded in Liber 1 of Plats, Page 18, Livingston Township, Otsego County, Michigan.

On February 27, 1997, Livingston Township and the City of Gaylord entered into a Joint Agreement for Conditional Transfer of Property pursuant to PA 1984 No. 425. The contract provided for the transfer of the subject property in three phases: C-1, C-2, and C-3.

The owner of Otsego Club has requested that the following parcels, being part of the original C-2 parcel, be excluded from the agreement and returned to Livingston Township's jurisdiction:

Parcel Nos. 102-540-034-001-00, 102-540-026-002-00, 102-540-034-002-00, 102-540-027-002-00.

The City Council has given due consideration to the following factors including but not limited to: land area and land uses, assessed valuation, probable growth, increase in business and commercial development, the present cost and adequacy of governmental services in the area to be transferred, the probable future needs for services, the practicability of supplying such services to the area to be transferred, the probable effect of the proposed transfer and of alternative courses of action, the probable change of taxes and tax rates in the area to be transferred, and the ability of the City to provide utility services to the area to be transferred.

The City has provided notice and held a public hearing on the proposed transfer as required

by MCL 124.24.
