Capital Fees assess due to an increase in square footage of an existing building or buildings shall be calculated on an individual basis using historical data.

CONNECTION FEE: Initial fee of \$200.00 per connection PLUS Inspection Fee if connection is made by a private contractor OR cost of actual expenses incurred if connection is made by City. Actual expenses include personnel, equipment and material costs. Fringe benefit rate will be determined by the current Leave and Benefit Rate as determined by MDOT Report of Employee Benefit Costs for The Municipal Fiscal Year (Form 455M)

FRONTAGE AND AREA FEES: Minimum fee of \$14.00 per front lineal foot plus an additional \$14.00 per lineal front foot for side frontage on corner lots in excess of 132 feet. In cases where an Area Fee computation would result in a great free than that provided by the Frontage Fee computation, Area Fees will be charged. Area Fees shall be computed at \$5.05 per square foot of property. Where previous development has occurred at a cost exceeding the \$14.00 lineal foot cost and paid for by a private developer, a different frontage and area fee will be utilized based upon as-built costs for wastewater main and appurtenances. *Frontage and Area Fees will not be assessed to platted lots in the Phase 1 Development of the Gaylord Industrial Park.*

MEIJER DEVELOPMENT FRONTAGE & LIFT STATION FEES: All fees based on lineal foot fee of \$129.91 with CPI annual escalator; base year 2008. Additional charges on pump station capacity fees of \$600 per one gallon per minute (gpm) of capacity impacting both McVannel and Meijer Stations independently per station affected. Frontage and lift station fees paid directly back to Meijer until 2027 or until \$539,111 threshold in paybacks is reached. Fees will then be returned to typical fees established by the City.

INSPECTION FEE: Fee shall be based on actual personnel and equipment costs with a minimum fee of \$20.00. Fringe benefit rate will be determined by the current Leave and Benefit Rate determined by MDOT Report of Employee Benefit Costs for The Municipal Fiscal Year (Form 455M).

LABORATORY TEST: \$25.00.

PRIVATE SEWAGE DISPOSAL PERMIT FEE: \$200.00 plus Inspection Fee.

SURCHARGE FEE: \$0.40 per pound BOD and \$0.28 per pound SS, based on the daily average permit limitations exceeded for BOD and SS during a monthly period.

TAP FEE: One six-inch (6") wastewater tap is constructed at the property line of each lot in Phase 1 Development of the Gaylord Industrial Park. Fees will not be assessed for taps constructed by the City of Gaylord during the initial development of the Park. Property owners will be assessed the actual cost or a minimum fee of \$1,000.00; whichever is greater, for additional taps constructed by the City of Gaylord. Tap fees will not be assessed for additional taps constructed by a private contractor during the development of any individual property.

In cases where an Area Fee computation would result in a greater fee than that provided by the Frontage Fee computation, Area Fees will be charged. Area Fees shall be computed at \$0.04 per square foot of property. Where previous development has occurred at a cost exceeding the \$11.50 lineal foot cost and paid for by a private developer, a different frontage and area fee will be utilized based upon as-built costs for water main and appurtenances. *Frontage and Area Fees will not be assessed to platted lots in the Phase 1 Development of the Gaylord Industrial Park.*

MEUER DEVELOPMENT FRONTAGE FEES: All fees based on lineal foot fee of \$41.47 with CPI annual escalator; base year 2008. Frontage fees paid directly back to Meijer's until 2027 or until \$539,111 threshold in paybacks is reached. Fees will then be returned to typical fees established by City.

INSPECTION FEE: Fee shall be based on actual personnel and equipment costs with a minimum fee of \$20.00. Fringe benefit rate will be determined by the current Leave and Benefit Rate determined by MDOT Report of Employee Benefit Costs for The Municipal Fiscal Year (Form 455M).

LABORATORY TEST: \$25.00.

RECONNECTION FEE: \$200.00.

SURCHARGE FEE: \$0.40 per pound BOD and \$0.28 per pound SS, based on the daily average permit limitations exceeded for BOD and SS during a monthly period.

TAP FEE: One Two-inch (2") water tap is constructed at the property line of each lot in Phase 1 Development of the Gaylord Industrial Park. Fees will not be assessed for taps constructed by the City of Gaylord during the initial development of the Park. Property owners will be assessed the actual cost or a minimum fee of \$600.00; whichever is greater, for additional taps constructed by the City of Gaylord. Tap fees will not be assessed for additional taps constructed by a private contractor during the development of any individual property.

TURN ON/TURN OFF SERVICE: \$50.00.

WATER METER FEES: All water meters must be purchased from the City of Gaylord. Meter fees shall be based upon the actual cost of the meter and meter size.

### **STORM SEWER FEES**

Rates are as of July 1, 2012. All rates and fees are established by resolution of the Gaylord City Council. The City Council shall review and determine such rates annually.

BASE FEE, CONNECTION: Owner is required to make all connections.

AREA FEES: Area Fees shall be computed at \$0.16 per square foot of area served.
